

Camp Peniel Worker Application

Dear Potential Camp Worker,

Thank you for considering Camp Peniel. It is our desire to use willing and dedicated workers. The items below will make for a smoother camp and also help you determine if camp is for you.

1. The pastor's endorsement on the back is required for all workers. A position may not be available for those who do not send in their application (postmarked by June 19) for pre-approval. Workers not approved are charged \$50.00.
2. We all have discovered that camp is not a vacation. It is a time of eternal investment in young lives. Workers must be at least 18 years old. Counselors should be at least 19 years old and a mature adult; exceptions may be made for kid's counselors. Worker's underage children by permission only, 3 years or older \$25.00
3. Counselors and workers create the atmosphere of the week by their personal attitude, enthusiasm, cooperation, humor, participation, and sportsmanship. Some campers know few mature Christian adults. Be a hero!!!
4. Campers respond well to high expectations. Correction should be given carefully and conclude at the camp alter. Corporal correction is not an option in the camp setting.
5. Counselors and workers have committed to a major task in the physical and spiritual oversight of campers. Prepare for good devotion times! All workers are expected to be on the campgrounds and post of duty, except in emergency. Notify director prior to emergency absence. Counselors should be involved in all activities.
6. Campers should not be at the dorms without their counselor. This simple rule will eliminate property damage, theft, mischief, and misunderstanding among campers. Let's emphasize the Christian's concern for others and their property.
7. **Workers Dress Guidelines.** Dress neat & conservative. No earrings, necklaces, body piercings, makeup, nail polish or acrylic nails. We suggest that workers wear sleeves to the elbow. Facial hair on Men workers is limited to a mustache. Conservative hair style, off ears, eyes & collar. Dress length for Ladies workers is two inches below the knee. Slits in skirts must be below the knee at all times. Thank you for your cooperation.
